Action/Strategy (1)

Conduct professional development for teachers and counselor.

Progress

Teachers and administrative staff have attended professional development and training on how to better educate at risk students exhibiting inappropriate behaviors.

The staff are also implementing the MTSS process with fidelity. Students are being identified by low academic performance on summative assessments, formative assessments, benchmarks, and state assessments.

The MTSS process also works to identify and intervene with the students exhibiting inappropriate behaviors.

The administrative staff are monitoring the referral count, attendance, and academic progress of Tier II and Tier III students.

How Does it affect the dropout rate?

Students exhibiting inappropriate behaviors are more likely to be or become students who are at risk for dropping out of school. If the students' educational needs are met with a more individualized approach, the demonstration of inappropriate behaviors will decrease. This process minimizes the office referral process for students. The more the students remain in class, the more productive they become. This process minimizes the dropout potential.

Action/Strategy (2)

Assess 9th Grade Career Readiness

Students are being introduced to MS Choices program through the high school STEM program.

The counselor will be trained on MS Choices implementation and analysis.

Ninth Grade students are being encouraged to register and take the ACT assessment.

ACT Workshops are being offered to all students enrolled at the high school.

How Does it affect the dropout rate?

The ninth grade population is considered to be a critical group for dropout potential. Students who decide to drop out, tend to do it by ninth grade. If students are targeted for career readiness during this time period, there is a greater possibility that the number of seriously at risk students will decrease drastically.
